


#### Women's Career Workshops

This year, JLP held five Women's Career Workshops for local women as we continue to focus on our Business, Entreprenuership, and Leadership Skills for women (BELS) service area. JLP partnered with Elizabeth House, CASA Treatment Centers, Salvation Army, Walter Hoving Home, and IMPACT, to teach their clients important interview and basic job-training skills, and also equip them with a ready-to-use interview tote bag. The workshops had a total of 25 women in attendance, and 35 JLP members were able to volunteer. We are proud of the impact we have been able to make in the lives of women in need in Pasadena, and we look forward to continuing to develop and host the Women's Career Workshops for many years to come!

# State Public Affairs Committee (SPAC)

#### About CalSPAC

CalSPAC represents 17 member Junior Leagues in California (including the JLP) comprised of over 10,000 women who volunteer over 140,000 hours to 111 community projects, and give over \$1 million dollars annually to their communities.

Since 1971, CalSPAC has represented the interests of its member Leagues and their community projects to policymakers at the national, state, and local levels. CalSPAC advocates for legislation in: education, family support, health, human trafficking, and violence prevention. Since 1992, CalSPAC has sponsored six bills and co-sponsored three bills that are now California Laws. JLP is sponsoring AB 1976, AB 2243, and AB 2434.



#### 2018 SPAC Delegate Highlights

In 2018, JLP SPAC Senior Delegate, Kim Ferreira was nominated by her CalSPAC peers for the role of CalSPAC Co-Chair for 2018-19 League Year. Her expertise in legislation and advocacy will help Kim as she oversees the strategic development of the entire delegation. For the past two years, Kim was a member of CalSPAC's Health Committee, which is committed to advocating for better access to quality health care and prevention programs statewide.

During the 2017-18 League year, JLP SPAC Junior Delegate, Stephanie McKibbin was a member of CalSPAC's Violence Prevention Committee which is committed to addressing the impact of violence in our communities through prevention, intervention, and education. Thanks to Stephanie's hard work and dedication, CalSPAC voted to support AB 2243 authored by Laura Friedman. This bill would prohibit the admissibility of evidence that a victim or a witness to a violent crime has engaged in an act of prostitution. Stephanie is in communication with the author's office and other Assemblymembers to show CalSPAC's support for this bill.

#### August

#### Assemblymember Holden's Annual Block Party CalSPAC Summer Conference 1st Annual Legislator Open House

Attendees included: Senator Portantino, Assemblymember Holden's office, Senator Judy Chu's office, Pasadena's Mayor Tornek, City Councilmembers Wilson and McAustin, members of the JLP, and many more.

Attendees spoke in an informal setting at JLP headquarters about issues that matter most to the League and how they intersect with what our city and state leaders are working on this year.

Members attended a City Council meeting where we led the Pledge of Allegiance, spoke on record about the JLP's focus area in the community, and received a special tour of City Hall by one of its historians.

#### November - April

#### SPAC Education in JLP Committees

SPAC delegates spend a majority of their time outside of Pasadena as they analyze and support legislation at the state level. This advocacy work is fundamental to JLP's focus area and our community; it is also essential that all JLP members are educated and empowered in this process.

#### January

#### SPAC GMM presentation and activity

Since 1992, CalSPAC has sponsored or co-sponsored 13 bills. Sponsored legislation is not just signing our name in support, but drafting legislation from start to finish. The 13 bills fall into four different CalSPAC focus areas: Education, Health, Family Support, and Violence Prevention. We also moderated a game of matching legislation to the years when it was signed into law with the entire membership.

#### March

#### CalSPAC Winter Conference (JLP hosted)

The CalSPAC delegation meets quarterly to train and empower it's member leagues. The conference schedule rotates throughout the state. In 2018, Pasadena hosted the Winter conference on March 9 - 11. Delegates convened to review and discuss bills and voted to support over 25 pieces of legislation. **April**

# General Membership Meetings, Conferences & Training

#### **General Membership Meetings & League Training**



The League Training & Events Committee had a great year planning trainings and General Membership Meetings (GMMs) at new locations throughout the Pasadena area. We kicked off the year in September at Alverno Heights Academy where the Board and Council members were introduced. In October we went to WeWork and heard from Assemblymember Chris Holden on the "State of the State." November brought neighborhood meetings and a training on Google Drive and the Junior League website by Active members, Jessica Torres and Michelle Maestas Simonsen. The January GMM was at the CTRL Collective and we heard updates from the State Public Affairs Committee and the 2018-2019 Board was announced. In February we were hosted by Hillsides and had a fantastic training on financial planning from Sustaining member Wende Headley. Later in February, the fundraising committee and New

members participated in a fundraising training. March was our second round of neighborhood meetings and in April the committee placement fair was at Alverno Heights Academy, ending the year of GMMs where it started.



#### Junior League Conferences & Leadership Training

The Junior League of Pasadena is privileged to have multiple training opportunities from the Association of Junior Leagues International (AJLI). We kicked off this year with Southwest Exchange hosted by the Junior League of Tucson, Arizona four members attended: Kim Ferreira, Jennifer Scibetta, Michelle Maestas Simonsen, and Charlotte Miles. Some of the topics covered were Community Impact, Membership Development, and Diversity. In November, Operations Director, Sara Hatch, and League Training and Events chair, Carolyn Cota, headed to Grapevine, Texas to participate in the Organizational Development Institute (ODI). Sara was focused on Membership Development while Carolyn was focused on Marketing and Communications. President-Elect-Elect, Sara Hatch; President-Elect, Charlotte Miles; current AJLI President and Past President of JLP, Carol Scott; Sustaining Members and Past Presidents Marah Lyvers and Mara Lague represented JLP at the Winter Leadership Conference in Long Beach, California which was attended by 336 delegates from 181 leagues. We were thrilled to have many involved members there, learn from the speakers, and exchange ideas. The 2018 AJLI Annual Conference was held in Memphis, Tennessee and was attended by President-Elect-Elect Sara Hatch, President-Elect Charlotte Miles, and the AJLI President Carol Scott.



#### 2018 Annual Meeting

The 2018 Annual Meeting was held on May 22 at the Rococo Room. The new members were installed as Active members and 7 Active members became Sustaining members. We celebrated Active members who had 5 and 10 years of service to the League. The volunteer of the year award was given to Candy Carlson and Stephanie McKibbin in recognition of their contributions. It was great to see so many members celebrate a great year!

### New Member Class 2017-2018

The Junior League of Pasadena had a wonderful 2017-2018 New member class! We had a diverse group of women from many different backgrounds and in many different professions, and they comprised the largest New member class in recent history. Our recruiting for this class began over the summer with four events around Pasadena. The first half of the year was spent introducing our New members to the League by training them on our history. We provided training on our community impact and the various roles and committees they will have the opportunity to volunteer on in the coming years. In the second half of the year we focused our attention on the New member project, PasadenaHelp.org. The New members helped us more than double the number of organizations listed in the database.

Being a New member is not all business. In addition to the monthly class meetings and volunteer opportunities, the New member committee organized a social event every month to give everyone a chance to get to know each other. Activities included the annual bus tour and team building, as well as an Oktoberfest themed party, happy hours, brunches, and volunteering to decorate a Rose Parade float!

The Junior League of Pasadena is developed as an outgrowth of the Junior Aid Society in Pasadena




Expanded support goes to the foothill Service Society, Junior Museum at the Pasadena Art Institute and the Volunteer Placement Bureau, all founded by the League
